4. Discuss modified R2.2.1

The SDT reviewed the modified R2.2.1 and had considerable discussion regarding the number of analysis which needs to be performed and/or verified. The standard was modified to clearly require an analysis be performed for Year One and an analysis must be performed or verified at a minimum for one year in the 2 through 5 year period and at a minimum one year in the 6 though 10 year period.

5. Discuss Definition for "Net Internal Demand"

Paul and the SDT reviewed the definition of "Net Internal Demand" and after discussion the SDT agreed to leave the definition as proposed and let commenters comment whether the definition needs to be modified.

6. Finish reviewing the Violation Severity Levels and Measures

The SDT finished reviewing the proposed VSL's and Measures.

7. Review and discuss proposed Implementation Plan

The SDT reviewed the proposed Implementation Plan and agreed with the language. Tony reminded the SDT that the current BAL-502-RFC-01 standard is still in effect and the proposed BAL-502-RFC-02 standard will simply be a continuation of the current approved standard.

8. Review FAQ document

Paul and the SDT reviewed the FAQ documents and modified it accordingly. Tony indicated that the FAQ will be posted along with the standard during the first 30-Day comment period for informational purposed. Additional FAQ may be added after the first comment period.

9. Develop Questions for 1st 30-day Comment Posting Period

Tony and the SDT reviewed the proposed questions for 1st 30-day comment posting period. Tony indicated that these were more "Generic" in nature and that the SDT may choose to make the 2nd 30-day comment posting questions more specific based on the comments received during the 1st 30-day comment period.
