Tony gave a high level overview of the Regional Standards Development Procedure which includes the following steps listed below.

- Step 1 Originator Submits Standards Authorization Request (SAR) to SPM, SAR comment period and Standards Committee (SC) action
- Step 2 Post request for DT and Appoint DT
- Step 3 Drafting of Regional Criteria
- Step 4 SC Authorizes 30-Day comment posting, DT responds to all subsequent comments
- Step 5 Category Ballot
- Step 6A Regional Criteria Passes Category Ballot and is forwarded to ReliabilityFirst Board for action
- Step 6B Regional Criteria Fails Category Ballot and SC action is requested
- Step 7 ReliabilityFirst Board Action
